Clerk reported that he had advised them the price quoted by Excell & Son which did not include the missing drag chain, which the state they are unable to procure. Cost of Repairs to Bratten Plow Excell & Son quoted £19.10.0 for repairs & replacements to Bratten Plow returned from WA Govt - which does not include 20' x 1" chain to replace drag chain. Apology received from Cr Doudle who was absent through a bereavment. On the Motion of Cr Morgan it was resolved to send a letter of Condolence to Cr Doudle & Family. Minutes of previous Meeting read & Confirmed. Financial Statement showed a Credit Bal of £3530.18.0.

Correspondence. Poonindie Cemetary Reserve Director of Lands advised that the Poonindie Cemetary Reserve was not dedicated and placed under the Control of any Body. Re JC Darke Centenary. Historical Memorials Committee of the Royal Geographical Soc of Aust S.A. Branch drew attention to the fact that The Centenary of John C Darke's Exploration Expedition occurs next year and that the Committee considers the Centenary should be recognised and the erection of a Memorial at Pt Lincoln, being one of the Main features and suggests that this Council, the Corporation and Flinders Memorial Committee

should form a Committee to carry out the erection of the Memorial. This was held over until next Meeting.

Resignation of Councillor Mortlock Ward Cr T.R. Fleming tendered his resignation as Councillor for Mortlock Ward as from 30th June 1943 as he will be leaving the District at the end of June. Cr Morgan in moving that the resignation be accepted with regret, said he was sorry to lose Mr Fleming as a Councillor as he had been a great assistance to the council and had done so much for the Cummins District, and especially in Health Matters, and wished him every success in the future.
