

District Council of Lincoln Minutes of Meeting held on 17 January 1941 Present Crs WG Morgan (Chair) Jas Doudle, CK Ritchie, RF Richardson, & GP Roe, also Clerk AH Taylor, & Overseer KS McFarlane. Minutes of previous meeting read & confirmed. Financial Statement presented Showed an O/D of £577. Correspondence Commr Highways asking Council to define by Section Nos the route of road from Flinders Highway to Edillilie that Council desires placed on Main Road Schedule, and also reasons for such proposal. Clerk to reply. Re Main Road Grant - Commr Highways advising that £500 of the £1000 MR Grant for Main Road No 42 may be utilised to recoupe expenditure out of Rates on the Cummins - Wildeloo Section of road during 1939/40 as per his letter of 18 Dec 1939, and £500 to be spent on this road. Greek Soldiers Fund Lady Barclay-Harvey } letter to Chairman requesting him to organize collections for Funds for Greek Soldiers - This letter was received too late to organize collections. Prop Cr Ritchie/ Sec Cr Doudle } That letter of acknowledgement be sent & that £5.5.0 be donated out of Council Funds. Carried. Annual Licence Cancelled. Director of Lands advised that Licence No 4465 to Mrs EM Kearns to occupy Camp Site at Kellidie Bay has been cancelled.

Camp Site- Director of Lands advising that Annual Licence had been approved to Mrs DE Bright to occupy Camp Site at Kellidie Bay from 1/1/11. Refund of Rates. J Solomon made application for the refund of rates paid by him after the property occupied by him had been declared and Aboriginal Reserve. Prop Cr Richardson/Sec Cr Doudle } That £4.4.0 the amount of Rates paid after the land had been declared an Aboriginal Reserve, and therefore not rateable, be refunded to J Solomon. Carried. Loc Govt Assoc Secy Local Govt Association requesting that any business for Half yearly meeting of the Association in March be forwarded to him by 31 January. Re draining Warrow Road AW Siviour Cummins, re draining of water from Warrow Road and requesting permission to roll and burn scrub on South side of road adjoining his property pt Sec 3 Hd Cummins, and that a drain be made along his boundary. Prop Cr Doudle/ Sec Cr Richardson } That this be held over and that Cr Roe and Overseer inspect the road and confer with landholders adjoining, as to what assistance they will give, and also the best place to make the drain and report back to the Council. Re drain from Road near Ningana. EL Robinson wrote re draining water from the road to a proposed dam on his property Sec 16 Hd Shannon. In the absence of Cr Smith, this was held over pending an inspection by Cr Smith & the Overseer. Secy Hospitals Dept advising that Mr C Grosvenor's name was omitted from the appointments to P.L Hospital Advisory Committee as previously advised.

Re Hospital Rating. Director General of Medical Services advising that Council's request for a reduction of the rating contribution to P.L Hospital, cannot be entertained, and giving reasons for same. Principally that the amount charged on A/c of P.L Hospital is considerably less in proportion than all other Hospitals. Clerk was instructed to acknowledge the letter & to state that the Council is still not satisfied that the method of Rating is equitable in comparison with that of P.L Corporation. Plan of Road RW Paynter stated that he would prepare fresh plan, which will be necessary in connexion with the exchange of old area for proposed new road through Sec 20 Hd Cummins. Vermin Inspector- Prop Cr Richardson/ Sec Cr Roe } That Parker be instructed to commence an inspection at once, and that the Overseer give him other employment if possible, between inspections. Carried. Overseers Report for month was read. Prop Cr Ritchie/Sec Cr Doudle } That Overseers report as read be adopted. Carried. Curator Mt Hope Cemetery- Cr Doudle moved/ Cr Ritchie sec} That Daniel Kennedy Speed be appointed Curator of Mt Hope Cemetery in place of HF Myers who resigned. Carried. Re Bitumen Road PL to WhyallaCr Ritchie drew attention to the development and expansion of Whyalla, as a market for live stock and produce from this end of the Peninsula, and the necessity for Councils concerned to do all they can to foster this market. Moved by Cr Ritchie/ Sec Cr Richardson } That this Council

communicate with the D/C of Tumby Bay, Cleve, and Franklin Harbour and Corporation of P.L with the object of appointing a deputation to wait on the Commr Highways to urge the completion of a bitumen road from Pt Lincoln to Whyalla at the earliest possible date. Carried. A deputation, Messrs GB Ritchie & Cassanova waited on Council to request a reduction in the rate charged as Rent for roads in the rough limestone and sandy Country in Hds of Uley & Sleaford.

Re Road Rents - and pointed out that the Govt rental for this Country averages about ½d per acre and requesting that the rent of roads be reduced to that rate- This was left over until next meeting when Clerk is to submit a list of roads affected. Requests Cr Roe requested that the road be reconditioned from the Cummins Cemetery to the Pipe track. Granted. Also that 15 chains be graded & covered on road between Messrs Fuss & Jericho. Granted. Also that the plant commence grading from Edillilie towards Warunda as soon as available. Letter to Blacker & Blesing - Also that a letter be written thanking Blacker & Blesing for their cooperation in Fire prevention activities - in storing & taking care of Councils equipment and in the installation of a Siren at their premises. Clerk to attend to this. Cr Roe stated that Mr Starke wants the low scrub rolled on the road between Sections 28/29/40 Hd Mortlock. This was left to Cr Roe and Overseer to inspect. Cr Roe also requested that the street from Cummins P.O to School be regraded while the plant is at Cummins. This to be done. Electric Lights Cummins Streets. Carried. Coffin Bay Road Highways Dept- Copy of letter to Corporation with consent to them spending £50 on improvements to Coffin Bay Road. Roads OpeningSurveyor General re adjournment of the opening of Road through Sec 20 Hd Cummins & stating that any further proposal must be submitted with new Plan and further deposit fee. Thanks - Treasurer Greek Soldiers Appeal, conveying the thanks of Lady Muriel Barclay-Harvey for Councils donation to their Fund together with receipt for same. Director of Lands advising that approval had been given for HW Wheeler of Warramboe to occupy 10 acres in SE corner of Section 55 Hd Shannon. Re War Loans & War Saving CertificatesC/W Treasurer and Organising Secy } wrote re urgency for increased War Loans and War Saving Certificates and requesting continuance of Council's cooperation. Cr Roe/ Cr Doudle } That Clerk acknowledge and state that Councillors

are acting in all Wards in an endeavour to further the Treasurers requirements. Carried. Re Military Information - Commandant 4th Military District Keswick re persons applying for information that may be of Military importance- and stating that no information should be supplied to unauthorised persons. Re Recruiting - Deputy Director of Recruiting - pointing out the necessity for further extensive recruiting and the type of recruits required. Donation - Secy Tubercular Soldiers Aid Socy re Annual Appeal & Sale of Tokens on March 7th. Prop Cr Smith/ Sec Cr Roe } That the Council donate the sum of £1.1.0 as previously. McDonald PA wrote requesting repairs be done on road adjoining their property Hd Wanilla - Overseer to inspect & report. Re Permission to Lease Road - Jericho FJ applied for Lease of portion of Mt Hope Road adjoining his property pt Sec 17 W Hd Cummins for cultivation purposes. Prop Cr Roe/Sec Cr Richardson } That application be made to Minister of Local Govt for permission to lease this road. Carried. Re Footpath & Roadway - Wemyss Mr IE Requested that Footpath be formed on South side of Tumby Bay Road and also that road to Neptune Oil Coy Depot also be formed. Prop Cr Roe/ Sec Cr Smith } That Overseer submit estimate of cost of approx 20 chains of footpath, but as the traffic does not warrant the expenditure necessary for the forming of the road, this to be left for the present.

Carried. Hardie EG wrote explaining that the burning of stubble on his property on 4 Jany before the date allowed by the Bush Fires Act, was done by an employee during his absence in Cummins, without

Re Scrub Fire his authority, and through a misunderstanding as to the date. Prop Cr Roe/Sec Cr Smith } That a strong letter be written pointing out the seriousness of the offence, and the penalty that can be inflicted, and that Legal action will be taken if any further breach of the Act occurs. Carried. Notice- Also that Clerk insert a notice in Local Newspapers, stating that the provisions of the Bush Fires Act will be strictly enforced in future. Carried. Report- Fire Controller RR Wilson also reported on the fire at EG Harders at Karkoo on 29th Janry. Re Fire Byles Bros- Starke WH Fire Controller reported having taken Firefighting material to Byles Bros property in response to a call from them. Also account for 2 Galls petrol used in going to this fire. Prop Cr Roe/ Sec Cr Ritchie} That Clerk reply, Council is grateful for what Mr Starke had done, but no provision had been made for payment by the Council in such cases, and suggest that the account be sent to Byles Bros who gave the call for protection to their property- Ration tickets which are provided for to be sent to Mr Starke. Carried. Re Proposed Drain Warrow M Road- Fuss Albert protested against storm water being diverted from flowing into his property Section 17 SW Hd Cummins as suggested, to drain the road. Reply, matter held over. Cr Roe & Overseer reported on the result of the meeting of landholders interested in the draining of the water from the Main Warrow Road, and Mr Fuss' objection to the drain being constructed. Clerk was instructed to write for an opinion from Local Govt Association Solicitor as to Councils Authority in the matter. Lincoln - Whyalla Road - Re Proposed Deputation to urge bitumenising of road Lincoln to Whyalla at earliest date-

Re Deputation - Corporation replied - Stating they were in favor of same, and that the Mayor Mr RF Poole had been appointed as a delegate. Secy P.L Chamber of Commerce wrote Stating they were prepared to assist in any way and offered the services of Mr JE Crotty on the Deputation at no expense to the Council. Clerk to acknowledge & accept the offer of Mr Crotty as a member of Deputation. Secy Local Govt Association - Notice of Half Yearly meeting to be held on 14th March, also copy of Agenda of business to be discussed. Rec'd. re Opening Road Hd Cummins- Prop Cr Roe/ Sec Cr Smith} That the minute passed at last meeting of Council adjourning the opening of Road through Section 20 Hd Cummins be rescinded, and that the opening of this road as advertised in Govt Gazette be rejected and a fresh application be made, including the transfer of old road. Carried. Reduced rent of certain Roads. - In reference to Deputation that waited on Council at last meeting requesting a reduction of Road rents in Hds Uley, Sleaford, & Flinders, Clerk submitted a list of same as instructed. Prop Cr Ritchie/ Sec Cr Richardson} That the rent of these roads be reduced to ½d per acre from 1st July 1941. Carried.

Overseers Report was read. Prop Cr Smith/ Sec Cr Roe} That overseers report as read be adopted. Carried. Re Cost of Blinding- Prop Cr Ritchie/Sec Cr Doudle} That the price for supplying & Blinding at Lake Hamilton be left to the Overseer to arrange with the Contractors. Carried. Cr Ritchie requested that a fortnights work by two men be done on road adjoining Block 4 Hd Uley. Granted. Cr Smith reported that excellent work had been done by the Patrol Grader in the Yeelanna District. Prop Cr Smith/ Sec Cr Ritchie} That Council write to Elliston Council in reference to combined action being taken to obtain a Special MR Grant for Edillilie - Kyancutta road, as the increasing traffic makes this necessary. Carried. Cr Smith requested that the following work be put in hand as soon as possible. 1 Mile of Grading on Road 42 near Kaldow. 1 Mile of regrading at Wilsons Hill near Yeelanna. 1 Mile of grubbing on road near Kaldow. Patches of gravel topping be done on Kapinnie Road between Yeelanna & Ningana. Granted. Also that Overseer prepare an estimate of cost of scooping sand off road between Freemans & Habners. Cr Roe requested that the following work be done :- 15-20 chains grubbing on road between Bryants & Mickans & also some grading. That some covering be done from Pillana Crossing to Marble View. Re Corners at Railway Sidings at Railway sidings are a danger to the travelling public and that action should be taken to endeavour to have these corners cut off. District Council of Lincoln Minutes of Meeting held on 21st March 1941 Present Cr W G Morgan (Chair) (Jas Doudle, C K Ritchie, R F Richardson, & G C Smith also Clerk A H Taylor & Overseer K S McFarlane. Apology received from Cr Roe for non attendance. Minutes of previous meeting read & confirmed. Financial Statement showed a Cr Balance of £2287.15.5 Correspondence - Secy to Minister of Local Govt advised that Councils application for permission to lease road to F J Jericho will receive consideration. Proposed Deputation Adjourned/ Minister of Local Govt advised that owing to the shortage of Bitumen and the necessity of concentrating personnel & plant on Defence works there is no possibility of the bitumenising of the Pt Lincoln - Whyalla road being undertaken for some considerable time, and that under the circumstances, a Deputation at this juncture would serve no useful purpose, but that should the position improve, the matter could be again reviewed. Clerk reported he had posted a copy of this letter to the Councils concerned, also Corporation and Chamber of Commerce P.L.

District Council of Tumby Bay, Cleve and Franklin Harbour also wrote advising they were in favour of a deputation and that they had each appointed a delegate to same. The deputation is now cancelled for the present.

Patrol Grader. The Highways Dept advised that they have no Patrol Grader that could be made available to this Council, but that consideration would be given to a request for a loan to assist in the purchase of one if full particulars were submitted. Clerk reported that on receipt of this letter he had

written for quotes from the firms that supply these machines, and several replies were tabled - Power Plant Ltd also sent their representative who waited on the Council with specifications and price. The matter was held over for considerations by a full Council. M R No 42 Highways Dept also advised that Councils request that the road from Flinders Highway to Edillilie be placed on Main Road Schedule will receive consideration, in the next general revision of the M R Schedule, also that the needs of this road will be considered when allotting the District Roads Grant for next year. Received.

Opinion- Secy Local Govt Association wrote with a copy of opinion of the Association Solicitor in reference to diverting flood water from road. Received. Hospital Contribution. Director General of Medical Services notified that the amount of contribution required from the Council for P. L Hospital for current year is £194.13.9 Recd

Department of Information forwarded illustrated matter in connexion with the prosecution of the War - one copy of each had been sent to Cummins Institute as requested.

Director of Recruiting A I F requesting assistance in obtaining increased enlistments which are urgently needed. Clerk to reply that members of the Council will do all they can to obtain same. Simultaneous Destruction of Vermin - Director of Lands wrote re Summer period and asked for statement of Action taken and the results. Clerk to supply the information. Emergency Night Landing of Planes. National Safety Council wrote re the necessity of organising for this and enclosed plans of proposed arrangements and particulars of the requirements. Clerk to write for further copies of the plans.

Re proposed Bird Sanctuary - Corporation of P L forwarded correspondence from Flora & Fauna Committee in reference to this matter. Resolved that same be returned to the Corporation stating that Council is agreeable for them to take what action they think fit.

Wright W T Mt Hope requested that scrub be rolled on road from West Main Rd to his gate at Sec F52 Hd Kiana, and about 6 chains of this road in 3 boggy places be repaired. This was held over pending an inspection by Councillor and Overseer.

McNalley T J Tallala requested permission to use a Fumigator for destroying rabbits.

Cr Ritchie asked that an inspection of the Wine Shanty road by himself and Overseer and authority be given them to do what they consider necessary. Granted.

Cr Smith asked that Overseer inspect some washouts on road near Kapinnie and have the necessary repairs done. Granted Also that necessary repairs be done on Lawrences Hill. granted.

Sports at Poonindie Cr Richardson spoke about the Permit issued to C A Rogers to hold Patriotic Sports at Poonindie

African Daisy - Secretary to Minister of Agriculture (in reply to Councils letter of 14 Febry) stating that the question of African Daisy becoming a menace, was dealt with by the NW Advisory Committee, who reported that although the plant is an undesirable one, it is not considered to be noxious, and is easily controlled by cultivation. Received. PC Angove also reported on this weed, to the same effect and suggested that the plants be cut before flowering. Clerk Elliston D/C acknowledged receipt of letter to Commr Highways applying for additional Grants for Kyancutta - Edillilie Main Road, which he had signed and sent on. Minutes of previous meeting read & Confirmed. Financial Statement showed a Credit Bal of £773.9.5

Correspondence District Roads Grant Highways Dept advised the District Road Grant allotted for current year £350 and if funds are available later a further allotment will be considered. Re Karkoo-Warramboos M Road Highways Dept in reply to Councils letter of 25 Nov & stating the Commr has no objection to the Council approaching the C/W authorities in reference to MR Road No 42 Mr R W Pearson MP acknowledged Councils letter and stating he had written the Federal Minister on the matter of the Karkoo - Warramboos Road and also in conjunction with Mr Christian M P to Mr Badman MHR. Also 2 later letters in reference to this matter.

OA Badman MHR a letter received from the Prime Minister Mr Curtin stating the report submitted by Mr Badman from this Council will receive consideration.

Elliston D/C also acknowledged Councils Letter on the above matter and that their Council would support this Council and are writing to Mr Badman and also Mr Pearson MP on the matter.

Re Urgent Repairs to Aerodrome Department of Air following Councils consent to suggested arrangements, advised that A H Taylor District Clerk has been authorised to carry out, or cause to be carried out, on behalf of the RAAF, any urgent repairs to the surface of the P.L Aerodrome that may be necessary owing to Enemy Action, and as may be requested by the Commanding Officer of the RAAF Station or Unit.

Representatives for P L Hospital Advisory Com Secy Hospitals Dept. Stating that owing to the Council representatives on the Port Lincoln Hospital Advisory Committee (Messrs C K Ritchie and P S Sinclair) having to retire by effluxion of time on 31st. December 1941, it is necessary for the Council to nominate two representative for the ensuing year. Prop Cr Richardson/ Sec Cr Smith} That Council again nominate Messrs C K Ritchie & P S Sinclair on the Committee. Carried

Corporation of P L Accepting offer to pay half cost of repairs to road from Bitumen to Sanitary Reserve.

Re Deputation Corporation of P L Requesting Council to receive a Deputation from their Council to discuss necessary repairs to roads to Winters Hill and Coffin Bay & ramp on Winters Hill road. Clerk advised that the time fixed for the deputation is 2.30 pm today. Later the Town Clerk notified that owing to the Mayor being indisposed, the deputation is postponed.

Secy Yalluna Pty stating that copy of Councils letter re proposed deviation of road through Block 5 Hd Wanilla had been handed to Elders Trustee & Ex Coy. The Trustees of the late W T Mortlocks entailed Estate, and a reply may be anticipated from them. Prop Cr Roe/ Sec Cr Doudle} That permission be granted for a gate to be places there during the pleasure of the Council. Lands Dept - Copy of Notice re Opening & closing roads in Hd Cummins, order for which is to be made at this meeting - together with plan of same showing road dealt with and Permanent Marks.

Order to Open New and Close and exchange Old Road Prop Cr G P Roe/ Sec by G R Smith} that the following order to open New Road and Close and exchange Old Road in Hundred of Cummins be made. Carried unanimously.

Order to open New and close & exchange Old Road Whereas at a meeting duly held under the provisions of the Roads (Opening and Closing) Act 1932-1936, this Nineteenth day of December One thousand nine hundred and forty-one, it appears to us the District Council of Lincoln, that it is expedient and necessary that the lands hereinafter firstly described should be opened as a new line of road, and that the lands hereinafter secondly describe are no longer required for the purpose of a road; and it having been proved that the notice required by the said Act has been duly given, and that all other requirements thereof have been complied with, and no valid objection to the open of such new line of road or to the closing of such old road

having been made: Now, therefore, we The District Council of Lincoln, do hereby by virtue of the powers given by the said Act, order that a strip of land, 61 links wide being portion of part section 20 in the Hundred of Cummins, contained in certificate of title volume 1527, folio 149, and dividing said part section 20 from part section contained in certificate of title, volume 1527 folio 148 and connecting the main road adjoining the western boundary of railway land with the eastern boundary of section 22 held under certificate of title, volume 1701, folio 143 as delineated, coloured red, and numbered I in plan deposited with the Surveyor General, shall be forthwith opened as a new line of road: And do further order that the whole of the road one chain wide, dividing section 15 from section 20, as delineated, coloured green, and marked A on the said plan deposit there with the Surveyor General, shall henceforth be discontinued and cease to be used as a road; and do further order that the piece of land lastly described and heretofore used as a road shall be exchanged with A J Slater for the piece of land and firstly described, and that the same shall be vested in the said A J Slater, his heirs and assigns for ever.
