Minutes of previous Meeting read & Confirmed. Financial Statement presented showed a Credit Bal of £3,990.3.6. Correspondence Proposed Cairn "Tallala".- Secy Highways Dept in reply to Councils letter, that provided the Cairn proposed to be erected on Lincoln Highway at the entrance to 'Tallala' is erected at least 10 feet clear of the constructed roadway, the Commissioner raises no objection to the proposal. Simultaneous Destruction of Vermin- Director of Lands Drawing attention to Summer period for the simultaneous destruction of Vermin- the Month of February and requesting that at the expiration of the period, a report be submitted to the Director. Legal Opinion re Poll- Secy Local Govt Association with Opinion of Association Solicitor stating that a Poll of Ratepayers cannot be taken on the question of the removal of Council Headquarters, as Polls can only be taken for specific purposes, as stated in L.G Act. LG Assoc Annual Meeting- Local Govt Assoc re Notices of Motion for the Annual Meeting to be held in March next. Secy EP Local Govt Assoc advised that the Annual Conference will be held at Cowell on 25th March or 1st April, and any matter for the agenda to be submitted by end of February, and names of Council delegates to be submitted as soon as possible.

Re 'Salvation Jane'- Secy Pt Lincoln Agricultural Bureau, requesting Council to endeavour to have the plant 'Salvation Jane' declared a Noxious Weed. Corporation of Port Lincoln stating they have no plant suitable for the necessary work on the road to Winters Hill. EW Jones and WW Gerschwitz both wrote pointing out the bad state of the road from Pillana School to the Warrow Road, used

by Area School Bus and requesting that same be repaired. Overseer to see if arrangements can be made for Hire of Tractor to work the Council Grader.

Nominations P L Hospital Advisory Com Hospitals Dept stating that nominations are required as soon as possible for two members to represent the Council on P.L. Hospital Advisory Committee for current year. - the retiring members being C K Ritchie & PS Sinclair for current year . Clerk advised that he had sent on the nominations of P Woods and P S Sinclair as directed at the last meeting of the Council.

Managing Director of Yalluna Pty stating that instructions had been given for the opening of the road at Section 272 Coffin Bay Homestead as requested.

Earl & Son in reference to roads to Section 7 Hd Mitchell. This is a main road & nothing can be done at present owing to shortage of Labour & plant.

Application to Lease portion of Road Proper Bay S A Fishermans Cooperation Ltd wrote and Mr J C Dunn waited on the Council to support the application to lease portion of the road between the south boundary of Sec 502 Hd Lincoln and High water mark, not used for road purposes. For the purpose of erecting a building for the processing, freezing and chilling Fish, Land required 45' x 60' up to High Water Mark. Director of Lands advised that this land is portion of district road and under the care of this Council - and that if any portion of it is not required by the Public - Council can deal with it under the Roads Opening & Closing Act, but suggested consult Councils Solicitor.
