# Improvements to Council cemeteries

Construction has begun on the Cummins Cemetery carpark. These works involve the formalising of the car parking area to the south of the entrance, to make the most efficient use of the area while improving the surface for those with mobility issues. The work is being undertaken for Council by Modra Earthmoving and is expected to be completed by May 15, weather dependant.



Council has also installed information/ entrance signs at its five cemeteries at Cummins, Wangary, Coffin Bay, Mount Hope and Coulta.

#### Draft Budget 2020/21

On May 4 Council had a workshop to consider the first draft of its 2020/21 budget. Council will advise when the 2020/21 budget is available for public viewing and comment.

# Patrol grading

The winter patrol grading program has commenced starting with the following roads - Merintha Creek Road, Murray Drive, Charlton Gully Road, Coles Point Road, Greenly Beach Road.

Council's two patrol graders, along with the construction graders when available, will concentrate on Class 1 and 2 roads in the first instance and only if conditions are ideal. Grading will move back onto Buckshot and Class 3 and 4 roads during times when conditions are not ideal.

Graders will be working in areas where there is a mixture

of different types of road surface materials, Green Patch, Wanilla, Coulta and Edillilie.



#### **Helipad complete**

Helipad bay at the Port Lincoln Airport is now complete and in use. The first helicopter used this new facility 90 minutes after line-marking was completed and opened.

# Hardship Policy / COVID-19 Assistance

Council have adopted a new Financial hardship policy to assist ratepayers who are experiencing financial difficulty, with the policy including reference to emergency events - refer council website.

In relation to the current health pandemic Council have resolved to waive fines and interest on payments for March through to August (inclusive) for those customers that can demonstrate a reduction of 30 per cent or more in business who income. or experiencing a reduction in working hours due to the COVID-19 pandemic.
