FAQs

WHAT CANNOT BE ACCEPTED?

- Asbestos
- Large building rubble
- Tyres
- Liquids/ dirty liquid containers

HOW CAN I PREPARE MY RECYCLING?

Separate by each category, and

- Remove metal fittings, nails, hinges etc. from wood
- Bundle newspaper
- Flatten and bundle cardboard
- Remove lids from glass bottles & jars

DO YOU OPERATE drumMUSTER?

Council facilitates a drumMUSTER collection every July and October. This service enables farm chemical users to return their empty, cleaned, non-returnable, steel and plastic farm chemical containers.

WHAT ABOUT BATTERIES?

Council has partnered with EcoCycle to now offer a battery collection service.

WHAT CAN BE ACCEPTED?

Cardboard

Means cardboard only. Care should be taken to ensure no other material contaminates the cardboard. Any contamination is likely to render the cardboard unsaleable. **No waxed cardboard, plastics, polystyrene foam, wood or metal.**

The following **can** be included, **glossy magazines, newsprint, milk and fruit juice containers, shredded and sheet paper.**

Wood

Only **clean unlaminated timber** should be stockpiled for grinding. **Nails and screws are okay** but **no large metal attachments**, bolts, hinges or metal pelmets etc.

Permapine and timber that is contaminated with metal or laminates that cannot be removed easily will go into landfill.

Glass

Bottles and jars, window panes go into landfill. Lids **must be removed** but labels are okay.

Plastics

Main types – milk bottles, clear juice containers.

Metal

No separation of light and heavy metal.
Aluminium, copper and lead kept separate
Lengths of colourbond/corrugated iron

Batteries & Gas Bottles

Waste Oil

Clean uncontaminated oil only.
No coolants

Whitegoods

Fridges/freezer, air conditioners

Fluros

Paint/Paint Tins

Paint tins containing no liquid (paint can be present but must be dry) can be placed in the residual waste bin or taken to the transfer stations. No wet paint is to be placed in bins or taken to Waste Transfer Station..
