The draft budget will be released for public consultation on June 9, with written submissions to close on July 3. Members of the public will have the opportunity to ask questions and verbal make а Council to submission 9am-10am between another special meeting on July 6 before the budget is formalised for adoption at Council's ordinary meeting on July 17.

Hardship Policy

Council has adopted a new Financial hardship policy to assist ratepayers who are experiencing financial difficulty, with the policy including reference to emergency events - refer council website.

In relation to the current health pandemic Council have resolved to waive fines and interest on payments for March through to August (inclusive) those for customers that can demonstrate a reduction of 30 per cent or more in business income, or who are experiencing a reduction in working hours due to the COVID-19 pandemic.

Council has included a range of other options in its draft budget and Annual Business Plan to support businesses whose revenue has been impacted by the Covid-19 health pandemic, and to support community groups and sporting clubs including:

- Non-essential businesses impacted by a directive issued by Commissioner of Police
- Accommodation providers where premises are used solely for business purposes and the provision of accommodation is the primary activity conducted from the land
- Coffin Bay, North Shields and Cummins Caravan Parks
- \$300 cash contribution to community and sporting clubs that were required to close due to COVID-19 to meet their fixed costs.

Oyster HQ car park

Council has taken part in an inspection ahead of making a decision on Oyster HQ's application to build a carpark on the Esplanade in Coffin Bay. Council staff and Elected Members will further consider the issue at the June Council meeting.

Facilities & services

While playgrounds, skate parks and campgrounds have been reopened, the following Council assets / services currently remain closed or suspended: Council owned & operated public BBQs; hiring of the community bus; Creating Connections (over 50's program); and The Cummins Institute (including the public toilets).

While Community Halls have been permitted to reopen by the State Government, the Cummins Institute is being utilised by a third party for the provision of health services at this time, therefore reopening cannot yet be facilitated.
