Correspondence Highways & Local Govt The Secretary advised that the matter of placing the Old West Road on the Main Road Schedule is being referred to the Corporation of Port Lincoln, which is also effected, but on the distinct understanding that if the Old West Road be included in the Main Road Schedule, portion of the existing West Main Road would be deleted therefrom.

Simultaneous Destruction of Vermin The Director of Lands drew attention to the Summer Period gazetted for Simultaneous destruction of vermin within this district, the month of February, & stated that the provisions of the Vermin Act in this respect should be strictly enforced.

Highways & Local Govt The Secretary advised the Commissioner is of the opinion that ramps should be provided on leased road, in cases where there is regular traffic on the road, & suggests this Council give further consideration to asking Mr Firth to put them in on the road through Section 13 Hd Cummins.

Director of Lands Informed the Council the Council Mr R C F Lear has been granted an annual Licence to temporarily occupy a quarter of an acre of Crown Lands fronting Kellidie Bay, opposite Sec 271 Hd Lake Wangary.

Counter Petition re sub division of Mitchell & Mortlock wards published in the Government Gazette of Sec 21 1933 & notified by the Highways & Local Govt to this Council.

Directions Signs The Automobile Association will supply signs in approved cases , if the Council will bear the cost in connection with transport & erection. Resolved a Direction Sign for Sleaford, Wanna to be obtained.

Correspondence Highways & Local Govt Department/ The Secretary advised, in view of the fact that the West Main Road is at present in better condition than the Old West Road, it is proposed to wait until improvement of the latter road is commenced by his department before varying the Main Road Schedule.

Culvert at Section 102 Hd Lincoln Comsnr Highways gave notice it is intended reconstructing this culvert; work to be commenced on approx 12th February.

Re Subdivision Mortlock & Mitchell Wards/ The Secretary required to know if the Council had any reply to offer to the competition opposing the subdivision, & if there is any evidence that ratepayers are favorable to the additional expense which would be involved in increasing the membership of the Council. The Council have no evidence that ratepayers are favourable to the extra expense. The Council is not in favour of it

It was agreed Council pay transfer and other fees for proposed new road; and Palm Brs grade the road 80 chains long x 30 ft. wide. A side drain to be put down, and a metal spoon drain constructed, near the railway line; at a total cost of £35.
