

District Council of Lincoln Minutes of Meeting held on 19th January 1940 Present Crs. WG Morgan, (Chairman) Jas Doudle, RF Richardson, CK Ritchie, GP Roe, & GC Smith. Also Clerk AH Taylor, Overseer K S McFarlane. Minutes of previous meeting read & Confirmed. Financial Statement presented showed a Dr. Bal of £265. Correspondence. Cummins- Wildeloo Main Road. Highways Dept in reply to Councils letter re cost of repairing Cummins - Wildeloo portion of Main Road No 42. & Stating that the Commr. had approved of the work being undertaken by the Council and that £300 can be recouped from the Main Roads Grant for 1940/41 & favourable consideration will be given to recouping the balance, £200, if funds are available. Prop Cr. Roe, Sec Cr. Smith That the work on Main Road between Cummins & Wildeloo be carried out in terms of the letter, (No 1547/39) from Highways Dept. Carried. Highways Dept Re Bitumen to Fountain. In reply to Councils letter, stating that Commr. is unable to give favourable consideration to the Bitumising of the 12 Miles of West Main Road to the Fountain at this juncture. Prop Cr. Smith, Sec Cr. Richarson That Cr. Ritchie be appointed as a Deputation to wait on the Commr. Highways & Minister of Local Government, and again urge the importance of this work being undertaken at the earliest possible moment. Carried.

It was also resolved that the Co-operation of the Corporation of Port Lincoln be requested in this matter.

Census of Traffic on West Main Road. Prop Cr. Ritchie, Sec Cr. Roe That a Census of traffic on West Main Road be taken for one week from Henders Corner. Carried. Overseer to arrange for this to be done.

District of Lincoln Order to open new, and to close and exchange portion of old Roads. Minute moved by Cr. C.K.Ritchie, seconded by Cr R.F. Richardson and carried, as follows:- "Whereas at a meeting duly held under the provisions of the Roads (opening and closing) Act 1932-36, this twentieth day of December 1940, it appears to us, the District Council of Lincoln, that it is expedient and necessary that the lands hereinafter firstly described should be opened as new lines of roads, and that the lands herein-after secondly described are no longer required for the purpose of a road, and it having been proved that the notice required by the said Act has been duly given, and that all other requirements thereof have been complied with, and no valid objection to the opening of such new lines of roads or the closing of such old roads having been made. Now therefore, we, the District council of Lincoln do hereby, by virtue of the powers given by the said Act, order that; First, in the Hundred of Lincoln, a deviation generally one chain wide of portion of the road dividing section 217 from portions of Sections 216, 56 and closed road, commencing at a point in the said road at the bend on the south-western boundary of said section 217 and continuing in a south-easterly direction through section 216, closed road and section 56 to meet the road intersection the north-western portion of the latter section. Second, in the Hundred of Wanilla, a strip of land 34 links wide portion of blocks 5B and 5D extending south-westerly from the north western corner of the former block to the southern boundary of the latter block, and two triangular portions of block 5B situated on the western boundary thereof, at about 30 and 60 chains distant respectively from its north-western corner, as delineated, coloured red and numbered 1,2,3,5,6,7,8 in map hereinafter referred to, shall forthwith be opened as new lines of road: and do further order that all that portion of the road, in the Hundred of Lincoln above-mentioned, dividing section 217 from portions of sections 216, 56 and closed road excluded by the deviation firstly above described together with a small triangular portion of the road on the eastern boundary of said section 217 extending northerly for a distance of 3467 links from the south-eastern corner thereof, as delineated, coloured green and marked A,B,C, in said map, deposited with the Surveyor-General, shall henceforth be discontinued and cease to be used as a road, and do further order that the piece of land lastly described, and heretofore used as a road, shall be exchanged with Mrs KM.
